In the region of small business loans provides 13 banks, "Sberbank of Russia", "Baykalbank", "Promsvyazbank", "Binbank", "VTB 24", "Rosbank", "Rosselkhozbank", "Asian-Pacific Bank", "Rosgosstrakh Bank", "OTP Bank", Bank "Avangard", "SKB-Bank", "The Ural Bank for Reconstruction and Development." Three of them also collaborating of "MSP Bank", a subsidiary of "Vnesheconombank". However, the "MSP Bank" does not conduct an independent monetary policy for the region's market, it only provides a cheaper resource to commercial banks-partners.

Banks offer to small businesses in the region a standard list of services: loans, overdraft, bank guarantees and leasing. However, their terms and conditions vary significantly. Interest rates on loans to banks in the range of 13.5% per annum on loans line of "MSP Bank" to 33% annually in the "Asian-Pacific Bank". Some banks lend only to its loyal customers, other loans those companies that are located in the daily availability of their office.
