In article dynamics of a price index of products of agricultural industry of regions of the Central federal district during 2000-2014 is considered. It is shown that temporary ranks of volume of production

in current prices can be approximated by exponential models. From the point of view of an exception of influence of uncontrollable factors, the author offers to use in the analysis of regional indicators MNK-estimates of parameters of models - calculated values of amount of products in 2014 and indicator surplus coefficient. It is provided that dynamics of a price index of producers of products of agricultural industry in regions of the Central federal district during this period can be also approximated by exponential models, MNK-estimates of their parameters are received. A conclusion is provided that the price index of producers of products of agricultural industry can serve as the managing level indicator in regions.
